# GRAFTON TOWNSHIP REGULAR BOARD MEETING MINUTES MONDAY, August 18, 2014 7:30 p.m.

#### 1. Supervisor Kearns called the meeting to order at 7:30 p.m.

Trustee Zirk asked why the men in the Assessor's office keep getting trained when they have already been trained. Assessor Zielinksi explained that the IT guy, Ruperto designed the web page so well that additions are made in text format, not html and Supervisor Kearns explained that Candie had been trained to make the updates.

Loretta Wuich asked when the Grafton Assessments will be complete. Assessor Zielinski stated that they would be sent to the county on September 1<sup>st</sup>, and the county would then publish them.

Linda Moore asked when the broken link to the county assessor's office would be repaired. Assessor Zielinksi said that it would be the next day.
