B. Trustee Zirk requested Clerk Hurley add "Trustee Zirk stated that she was against the increase in salaries due to the high increase in health insurance which went up 13½%. She feels that was their raise."

She mentioned she is not sure if it was the current resident or the previous owner who installed the problematic landscaping. She said she spoke to her neighbor about the problem who said she had an exemption letter. Supervisor Kearns said he did not send one. Road Commissioner Poznanski said he didn't either but that he would address the situation making sure the proper ditches and culverts are in place.
