EXECUTIVE SESSION MINUTES Grafton Township Board January 18, 2016

The Executive Session of the Grafton Township Board was called to order by Supervisor Kearns at 7:48 P.M.

Present: Supervisor Kearns, Trustees Holtorf, Wagner, Ziller, Zirk; Clerk Hurley. Also present by invitation of the board was Attorney Gottemoller.

Absent: None.

PURPOSE

To discuss pending litigation and personnel issues involving the Township pursuant to 5ILCS 120/2(c)(11

DISCUSSION

Attorney Gottemoller explained that since the last Executive Meeting, there had been a deposition with Assessor Zielinski in which there was a lot of discussion about the Assessor putting Mr McKnight's information online in the blog. In that deposition, Assessor Zielinski admitted that he was mad at Mr. McKnight.

The Judge had already ordered the Assessor to give Mr McKnight the PIN numbers as part of his FOIA request. Due to the events in the deposition and Assessor Zielinski's blog posting, the township will have to pay Mr McKnight's attorney fees. He said the fees were 31 hours @ \$300 per hour. He gave the trustees the settlement letter from Mr McKnight's attorney at Loizzo & Loizzo requesting a total of \$17,000. (Exhibit I)

Attorney Gottemoller said he would write a settlement letter to the attorney. He said that the only things he can argue is that the \$300 per hour fee is too high, and to ask that it be a \$2,500 penalty not \$5,000. The higher penalty was issued because of Assessor Zielinski's admission that he was mad at Mr McKnight when he submitted his information on the blog.

The Trustees discussed various settlement offerings. They agreed to give Attorney Gottemoller the latitude to negotiate with a starting offer of \$8,000 for the attorney fees.


Motion was made by Trustee Wagner, seconded by Trustee Holtorf to adjourn the Executive Session at 8:12 P.M.

Now that the deposition has been taken and documents were turned over respective to the FOIA request, I have been authorized to make the following settlement proposal:


My attorney's fees are at approximately \$12,000. Inclusive of costs of suit and statutory penalty, we would be willing to conclude this matter for the total of \$17,000.
