TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 2020 Levy RBD

An ordinance levying taxes for all road purposes for Grafton Township Road
District McHenry County, Illinois, for the tax year 2020 , collectable in 2021.

BE IT ORDAINED by the Board of Trustees of Grafton Township,
McHenry County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Grafton Township Road District
on October 6th, 2020 does hereby determine and declare that the sum of Seven Hundred Twenty
Thousand, One Hundred Ninteen Dollars (\$720,119) are hereby levied
upon all property subject to taxation within the Road District as that property is assessed and equalized,
in order to meet and defray all the necessary expenses and liabilities of the Road District as required by
statute or voted by the people in accordance with the law, for such purposes as:

Road and Bridge Fund

Permanent Road Fund

Insurance Fund

IMRF Fund

for the year 2020.


