ordinance no. <u>Levy Road</u> District 2025 - 2026

An ordinance levying taxes for all road purposes for Grafton Township Road

District McHenry County, Illinois, for the tax year 2024, collectable in 2025.

BE IT ORDAINED by the Board of Trustees of Grafton Township,
McHenry County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Grafton Township Road District on November 18, 2024 does hereby determine and declare that the sum of Nine Hundred Forty Five Thousand One Hundred Sixty Eight Dollars (\$945,168) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
