The Regular Township Board Meeting of the Grafton Township Board, McHenry County, Illinois was held on Monday, December 15, 2025, at the Grafton Township Board Room, 10109 Vine Street, Huntley, IL.

2. **Roll Call**- Board Present: Supervisor Ruth; Trustee Cratty, Lawrence, Oltman-Ayers and Sac, Road Commissioner Kearns, Assessor DeBaltz, Attorney Gottemoler, and Clerk Watson.
3. **Pledge of Allegiance** was recited at Levy Hearing and not repeated.

A motion was made by Trustee Cratty, 2nd by Trustee Sac to approve the Agenda as presented. Roll call vote taken, all ayes noted, motion carried.
5. **Regular Business**
 - A. **Approval of Minutes Township Regular Board Meeting, October 20, 2025**
A motion was made by Supervisor Ruth, 2nd by Trustee Cratty to approve the Minutes of the Township Board Meeting dated November 17, 2025, as corrected (correcting the time of the Road & Bridge Levy Hearing to 7:30 p.m.). Roll call vote taken, all ayes noted, motion carried.
 - B. **Audit and payment of unpaid bills/Warrant check detail for Town Fund**
A motion was made by Trustee Sac, 2nd by Trustee Lawrence to approve the audit and payment of the unpaid bills/Warrant check detail for the Town Fund as presented. Roll call vote taken, all ayes noted, motion carried.
 - C. **Audit and payment of unpaid bills/Warrant check detail for Road District**
Supervisor Ruth noted that he did not have any involvement in the hiring of a vendor that he has a family connection to and will be abstaining from approving the Road District unpaid bills.

A discussion ensued regarding Frost Solutions with the Board.

A motion was made by Trustee Lawrence, 2nd by Trustee Oltman-Ayers to approve the Audit and payment of unpaid bills/Warrant check detail for the Road District as presented. Roll call vote taken: Trustee Lawrence-aye; Trustee Oltman-Ayers-aye; Supervisor Ruth-abstain; Trustee Cratty-aye; Trustee Sac-aye. Motion carried.

A. Discussion and possible action – Road District Levy 2026-202

A discussion ensued. The following are a summary of comments from members of the Board.

1. Attorney Gottemoller:

- Gave a history of Road District Levy in Township
- Board rejected Levy, went to court. Judge quickly ruled in favor of Road District
- 2nd time went to court again, same ruling
- 3rd time, if happens, Judge could charge contempt charges to Board members
- Advised Board that the "solution is in Springfield, not here"

2. Trustee Cratty

- "It's not about the money" it was about the process of the Road Commissioner.
- Reserves are needed but because of "changes to amounts since last meeting, will be voting no"

3. Trustee Oltman Ayes

- Understood the agreed percentages but not the change to 6% after Board meeting.

A motion was made by Trustee Oltman-Ayers, 2nd by Trustee Lawrence to approve the Road District Levy of One Million, Nine Hundred Two Dollars (\$1,000,902.00), a six percent (6.0%) increase as presented. Roll call vote taken, Trustee Oltman-Ayers-Yes; Trustee Lawrence – yes; Supervisor Ruth – yes; Trustee Cratty- No; Trustee Sac – Yes. Motion carried.

The Road Commissioner, Road District of Grafton Township, McHenry County, Illinois held a Public Budget Hearing to approve a proposed property tax levy for the Grafton Township Road District for 2026-2027 on Monday, December 15, 2025 @ 7:29 p.m., in the Grafton Township Board Room, 10109 Vine Street, Huntley, IL 60142

1. Call to Order – 7:30
2. Roll Call – Board Present: Supervisor Ruth, Trustee Cratty, Lawrence (entered meeting at 8:00 p.m.), Oltman-Ayers, Sac; Road Commissioner Kearns, Assessor DeBaltz, Attorney Gottemoller, and Clerk Watson.

3. Pledge of Allegiance was said.

4. Approval of the Agenda

A motion was made by Trustee Cratty, 2nd by Trustee Sac, to approve the Agenda as presented. Roll call vote taken, all ayes noted, motion carried.

5. Levy Increase Discussion

The estimated corporate and special purpose property taxes to be levied for 2025 are One Million Nine Hundred and Two Dollars (\$1,902,000.00). This represents an increase of six percent (6.0%).

6. Public Comment – A sign in sheet was provided asking for name/address.

Discussion ensued. The following summarizes the comments of the Road Commissioner, the Board comments and the Public Comments to the best of my abilities:

Road Commissioner Kearns:

- Recapped his reasons stated in prior meetings for the Levy increase as inflation, County discontinuing contributions to the Bridge Fund, and Capital Improvement (new truck estimated \$235,000-\$250,000).
- Noted that the assessed value for the Road was "\$19.00 in 2020, now \$12.00"
- Consulted with County after Board meeting on appropriate rate change. Advised that rate would be 5.44 but to Levy @ 6.0%

BOARD:

A. Wanted clarification of the numbers as the Levy was presented last month @ 4.99%, adjusted at meeting's end to 5.14% but the Levy was now 6%. "What does this look like to the taxpayers?"

Response: "County" advised an adjusted rate of 5.44% but to "raise his rate to 6%". RC Kearns could not present Board with a name from County who advised him to recalculate his rate as the conversation was held between his staff and the County.

RC Kearns response: Levy monies would "be going to permanent hard road fund".

B. Discussion ensued regarding Board's process in the Levy

- Board does not control the process
- Board approves his Levy
- Board controls his Budget
- If Board does not approve Levy, Town Fund will pay all Court fees
- Court will award his Levy as presented.
- "doesn't like how we got here"
- "as stewards of taxpayer's funds, we need to avoid court costs and vote to approve".

C. Discussion regarding Bridges not being covered by County were in original Levy, now again used as a response to why the increase.

D. How was this rate properly "determined" (process of Township Levy Procedures)

Response: Clerk Watson verified communication with Brian @ Township Officials of Illinois that a Levy is determined when it is posted/published.

PUBLIC COMMENT

A. Resident Susan Snyder

- Glad to see discussion and talking things through
- Black box not in Sun City's newspaper
- Where are the township bridges located?

RC Kearns response: North Union Road, the "S" curve on Union Road a half mile west; and Menching Road

Clerk Watson response: The law states that Black Box publication to be published in the "most populated" publication.

B. Resident Pam Mosier

- Regarding the change in the Levy amount, wanted "more transparency";
- Regarding the 5.14% change to 6.0%" in the name of transparency, but feels like a 'bait and switch'".

C. Resident Ann Minn

- Recalled heads up from RC on bridge situation as being mentioned in a November Board meeting,
- Gave her "understanding" of process for public clarification
- Noted that the County has final determination of the Levy request

6. ADJOURNMENT A motion was made by Supervisor Ruth, 2nd by Trustee Lawrance to adjourn the Road District Levy Hearing. Roll call vote taken, all ayes noted, motion carried. The Road District Levy Hearing was closed at 8:23 p.m.
