MONDAY, November 17, 2025

The Regular Township Board Meeting of the Grafton Township Board, McHenry County, Illinois was held on Monday, November 17, 2025, at the Grafton Township Board Room, 10109 Vine Street, Huntley, IL.

1. **Call to Order -7:30**
2. **Roll Call-** Board Present: Supervisor Ruth; Trustee Cratty, Lawrence, Oltman-Ayers and Sac, Road Commissioner Kearns, and Clerk Watson. Assessor DeBaltz was absent.
3. **Pledge of Allegiance** was recited.
4. **Approval of the Agenda**
A motion was made by Trustee Cratty, 2nd by Trustee Oltman-Ayers to approve the Agenda as presented. Roll call vote taken, all ayes noted, motion carried.
5. **Regular Business**
 - A. **Approval of Minutes Township Regular Board Meeting, October 20, 2025**
A motion was made by Supervisor Ruth, 2nd by Trustee Sac to approve the Minutes of the Township Board Meeting dated October 20, 2025, as corrected (correcting the time of Adjournment to 9:07). Roll call vote taken: Supervisor Ruth-aye, Trustee Sac-aye, Trustee Cratty-aye, Trustee Lawrence-aye, Trustee Oltman-Ayers-abstain. Motion carried.
 - B. **Audit and payment of unpaid bills/Warrant check detail for Town Fund**
A motion was made by Trustee Sac, 2nd by Trustee Lawrence to approve the audit and payment of the unpaid bills/Warrant check detail for the Town Fund as presented. Roll call vote taken, all ayes noted, motion carried.
 - C. **Audit and payment of unpaid bills/Warrant check detail for Road District**
Supervisor Ruth noted that he did not have any involvement in the hiring of a vendor that he has a family connection to and will be abstaining from approving the Road District unpaid bills.

A motion was made by Trustee Lawrence, 2nd by Trustee Cratty to approve the Audit and payment of unpaid bills/Warrant check detail for the Road District as presented. Roll call vote taken: Trustee Lawrence-aye; Trustee Cratty-aye; Supervisor Ruth-abstain; Trustee Oltman-Ayers: abstain; Trustee Sac-aye. Motion carried.

6. Public Comment –

A. Resident Phyllis James:

- i. Why are Public Comment questions not allowed during or when the discussions are being discussed??
- ii. Why is Road District pursuing a 4.99% Levy increase and not a 5.00% (and hold a Public Hearing)?

B. Resident Susan Snyder:

- i. Why the Levy increase of 4.99%?
- ii. Inquired if health insurance is provided by the Road District

C. Resident Ann Minn

- i. Are there specific projects earmarked for the increased cost?
- ii. Inquired why a 4.99% Levy instead of 5% and hold a Public Hearing

D. Resident Pam Mosier

- i. Asked why not Black Box 5.0% for the purpose of transparency

E. Resident Jordan Puliese

- i. Noted that the rise in inflation is 32% and the Road & Bridge is down 20%. According to his calculations, the Levy will be an increase of \$2.52 per person.

7. Board Response to Public Comment

Road Commissioner Kearns read a prepared statement as a response to all the above. A copy is attached and made part of these permanent records. Answers to public comment are as follows:

A. Resident Phyllis James comment:

- i. Supervisor Ruth gave comments on why public comment is allowed only during a specified time for public opinion, but the matters of the Township are handled/discussed / voted on by the Board Members only.
- ii. Why 4.99%: Road Commission Kearns gave the following explanation in part:
 1. "Cost escalation continues across multiple categories",
 2. "Major Equipment Replacements",
 3. "County's decision to discontinue its contribution toward bridge construction and repair due to a \$6 million budget shortfall", and
 4. "Despite these pressures, the Road District continues to perform a wide range of essential public safety and infrastructure functions".

B. Resident Susan Snyder: Response that health insurance is covered for the employees of the Road District.

C. Response to Resident Ann Minn:

- i. Project earmarked – "1999 plow truck is beyond serviceable life; replacing it now exceeds \$235,000. The 2006 John Deere end loader would cost roughly \$255,000 to replace.
- ii. Road Commissioner responded to all inquiries about why 4.99% instead of 5% and black box for transparency was to "hold down costs, did not think it was necessary

to incur additional costs of newspaper fees, etc.”, the Levy was straightforward and well done”.

D. Resident Pam Moser – response was given as above

8. Old Business –

A. Discussion and possible action – Town Fund Levy 2026-2027

A discussion ensued regarding the Town Fund Levy, including Supervisor Ruth noting that 8 years ago, the Levy for the Town Fund was 1.1 million dollars. Four years the Levy has been cut, 3 years the Town Fund Levy has been flat, and the Board abated the Levy one year.

A motion was made by Trustee Oltman-Ayers, 2nd by Trustee Cratty to approve 2026-2027 Town Fund Levy as a Flat Levy (no increase) in the amount of Six Hundred Twenty Thousand and 00/100 Dollars) \$620,000, with a 0% increase. Roll call vote taken, all ayes noted, motion carried.

B. Discussion and possible action – Road and Bridge Fund Levy

A. Supervisor Ruth gave the audience and new Board members the history of the Road Commissioner’s Levy history.

B. Trustee Cratty commented that “it is not the money but the principle” (5% with a public hearing better to taxpayers than 4.99% with no hearing). Also, Trustee Cratty noted that the money collected is lower because of the population increase.

C. Trustee Oltman-Ayers: “Why not hold a public meeting” and “important to build community trust”.

D. Road Commission responded to the Board as follows:

- i. He is completing 1 mile of road within budget “almost”
- ii. New equipment will be needed as “half of fleet is over 20 years old”;
- iii. He has depleted the reserve three quarters of a million dollars in the last 5 years;
- iv. Bridges will need to be repaired in the future; and
- v. The Levy fund will all go toward Permanent Hard Road Fund

A discussion ensued regarding the 4.99% Levy or a black box of 5.0% or more increase to offer a public hearing and black boxing the Levy in the newspaper.

Road Commissioner Kearns will Black Box the Road District Levy with a 5.15% (Increase) for 2026-2027 in the newspaper. There will be a public hearing on Monday, December 15, 2025 @ 7:00 p.m.

9. New Business – Discussion and possible Action: Publication of Levy in Newspaper

ROAD COMMISSIONER RESPONSE TO LEVY INCREASE OF 4.99%, Dated 11/17/25

Since 2020, the Road District's operating environment has changed significantly. Expenses have increased nearly 30%, while previous reductions to the levy created an ongoing shortfall. In 2018, the levy totaled \$854,428; however, by 2020 it had been reduced to \$720,119, a decline of \$134,309 annually (a 19% decrease). Although the levy was increased to \$820,965 in 2022, it still does not reflect current economic conditions.

From 2021 to today, the national inflation rate has risen 25%. If the levy had remained aligned with inflation, our current budget would be approximately \$1,026,206.25. This gap has made it increasingly difficult to maintain required service levels.

Cost escalation continues across multiple categories:

- Unemployment insurance has more than doubled this year.
- General insurance increased 10%.
- Salt costs increased 7.5%.
- Vendor labor rates increased 20% since January 2025.
- John Deere: \$190/hr o International: \$225/hr

Additionally, the district faces major equipment replacements. The 1999 plow truck is beyond serviceable life; replacing it now exceeds \$235,000. The 2006 John Deere end loader would cost roughly \$255,000 to replace.

Another emerging challenge is the County's decision to discontinue its contribution toward bridge construction and repair due to a \$6 million budget shortfall. Our township has three bridges that will require attention in the future, and the average cost of replacement is close to \$2,000,000 per structure. With the county's list already committed to seven remaining projects—none within our township—funding responsibility will shift entirely to us.

Despite these pressures, the Road District continues to perform a wide range of essential public safety and infrastructure functions, including:

- Road and ditch maintenance
- Sign and culvert repair and replacement
- Shoulder gravel upkeep
- Pothole and pavement repair • Road line and stop bar painting
- Tree trimming and removal
- Equipment, building, and property maintenance

- Winter operations: plowing and salting
- Assistance to the Sheriff's Office during incidents • Permit issuance

These responsibilities are carried out 24 hours a day, year-round, including nights, weekends, and holidays.

All services are delivered at a cost of approximately \$12 per \$100,000 of assessed value, which is notably lower than nearby townships:

- Algonquin: \$32.00
- Coral: \$53.00
- Dorr: \$82.00
- Seneca: \$53.00
- Greenwood: \$82.00

For historical context, the Road District tax in Grafton Township was approximately \$19 per \$100,000 in 2015, compared with \$12 per \$100,000 in 2024.

These figures illustrate the growing gap between required service levels, rising operational costs, and the revenue available to sustain them. Presenting this information supports informed decision-making regarding future budgeting and long-term infrastructure planning.

ORDINANCE NO. _____

An ordinance levying taxes for all road purposes for Grafton Township Road
District McHenry County, Illinois, for the tax year 2025 , collectable in 2026.

BE IT ORDAINED by the Board of Trustees of Grafton Township,
McHenry County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Grafton Township Road District
