Grafton Township Regular Board Meeting September 9, 2004

Call to Order

The regular meeting of the Grafton Township Board was held on September 9, 2004 at the Grafton Township Building, 10109 Vine Street, Huntley, IL 60142.

The following were present: Supervisor/Chairperson Ruth; Trustees: Hansen, Hight, Ziller and Zirk; Road Commissioner Cosman, Assessor Ottley. Clerk Watson was absent. Visitors are recorded in the "Audience Participation" section of these minutes.

The meeting began by reciting the Pledge of Allegiance, and Supervisor Ruth called the meeting to order at 7:30 p.m.

Minutes of Previous Meeting

Hight made a motion, seconded by Ziller, to accept the minutes as amended. Salary increases were amended to include amounts, not percentages. Approved salaries are attached and made a part of these minutes. Voice vote taken, all yes votes noted, motion carried.

Financial and Investment Report

Ziller made a motion, seconded by Hight, to approved the Financial and Investment Reports as presented. Voice vote taken, all yes votes noted, motion carried.

Presentation of New Bills

Supervisor noted the following:

- 1. 38 families and 122 individuals were served by General Assistance last month;
- 2. Locks on the door to the west (new addition) will be matched to the master key and the Assessor's employees keys.
- Painter will return for a second coat of paint in the new addition and will return later to repaint the Assessor's office and the current interior building.

Ziller made a motion, seconded by Hansen, to approve the Presentation of New Bills. Voice vote taken, all yes votes noted, motion carried.

Supervisor's Report

Supervisor Ruth presented the following items for review/discussion.

- Hight made a motion, seconded by Ziller, to transfer \$45,000 (Forty Five Thousand Dollars) from savings to checking. Voice vote taken, all yes votes noted, motion carried. Supervisor noted that there may be another pay out to the contractor and if that was necessary, additional money may be transferred.
- 2. There was an insurance discussion regarding the health insurance.

3. Salaries for next term must be in dollar amounts not as percentages. The salaries for the next term are as follows:

Road Commissioner's Report

Road Commissioner Cosman gave his monthly report and requested a transfer to \$50,000. Ziller made a motion, seconded by Hansen, to transfer \$50,000.00 (Fifty Thousand Dollars) from savings to checking. Voice vote taken, all yes votes noted, motion carried.

Clerk's Report -

It was noted that Clerk Watson responded to John Rossi's Freedom of Information Act with the requested materials.

Assessor's Report -

- 1. Electronic filing was investigated.
- 2. Due to IMRF retirement purposes, Assessor would like to be paid every two weeks. Hansen made a motion, seconded by Hight, to pay elected officials every two weeks with starting date of October 1, 2004. Voice vote taken, all yes votes noted, motion carried.
