An ordinance levying taxes for all road purposes for Grafton Township Road
District McHenry County, Illinois, for the tax year 2014 , collectable in 2015.

BE IT ORDAINED by the Board of Trustees of Grafton Township,
McHenry County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Grafton Township Road District
on December 15th, 2014 does hereby determine and declare that the sum of Eight Hundred Thirty
Three Thousand, One Hundred Seventy Four Dollars (\$833,174) are hereby levied
upon all property subject to taxation within the Road District as that property is assessed and equalized,
in order to meet and defray all the necessary expenses and liabilities of the Road District as required by
statute or voted by the people in accordance with the law, for such purposes as:

Road and Bridge Fund

Permanent Road Fund

Insurance Fund

IMRF Fund

for the year 2014.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Grafton Township Road District.


SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
