RESOLUTION 20120913, SETTING OF COMPENSATION OF TOWNSHIP OFFICIALS FOR THE FOUR YEAR TERM BEGINNING MAY 20, 2013 GRAFTON TOWNSHIP, MCHENRY COUNTY, ILLINOIS

WHEREAS, according to 60 ILCS 1-65-20, the compensation of township officers shall be set by the Township Board at least 180 days before the beginning of the terms of office.

WHEREAS, according to 60 ILCS 1-65-20, the compensation for the Road District Treasurer shall be fixed by the Township Board and shall not be less than \$100 or more than\$1,000 per year.

WHEREAS, according to 605 ILCS 5/6-207, the compensation of the Highway commissioner shall be fixed by the township board at an annual salary of not less than \$3,000 to be paid in equal monthly installments, or a per diem amount for each day he or she is necessarily employed in the discharge of official duties;

WHEREAS, according to 605 ILCS 5/6-207 a portion (not exceeding 50%) of the Highway Commissioner's salary may be paid from the Corporate Road and Bridge Fund, if approved by the Township Board and the Township Road Commissioner;

WHEREAS, the Township Board and Highway Commissioner have agreed and approved to have 25% of the Highway Commissioner's salary to be paid from the Road District's Permanent Hard Road Fund.

WHEREAS, during the term specified in this Resolution, 25% of the Highway Commissioner's salary will be paid from the Permanent Hard Road Fund.

WHEREAS, according to 35 ILCS 200/2-70, the compensation the Township Assessor and collector shall be set by the Township Board at the same time the Board sets the compensation of its Township Supervisor.

NOW, THEREFORE, BE IT ORDAINED BY Board of Trustees of Grafton Township that the compensation of the Township officials for the four year term beginning May 20, 2013 and ending May 15, 2017 (January 1, 2014 – January 1, 2018 for assessors and collectors) shall be as follows:

SECTION 1: The salaries for Township officials shall be as follows:

Supervisor's Salary: Effective for each of the following years: May 20, 2013 – May 19, 2014 \$ 40,000. ; May 19, 2014 – May 18, 2015 \$ 40,800. ; May 18, 2015 – May 16, 2016 \$ 41,616. ; May 16, 2016 – May 15, 2017 \$ 42,448. .

Road District Treasurer: \$ 500.00 ANNUALLY.
